ORDINARY SHAREHOLDER'S MEETING HELD ON 5TH OCTOBER 2011

Having been duly called, today, 5th October 2011, at 11:05 am in Padova, Settima Strada no. 15, the Ordinary Shareholder's Meeting of SAFILO GROUP S.p.A. was held.

Pursuant to article 2371 of the Civil Code and to article 11 of the Articles of Association, the Chairman of the Board of Directors, Melchert Frans Groot, acts as Chairman of the Shareholders Meeting and welcomes the shareholders and the members of the Board of Directors and the Board of Statutory Auditors who are present, as well as Mr. Robert Polet, who is participating via teleconference.

The Chairman declares not to perfectly understand the Italian language but to understand the English language and, in English, he informs of his intention to avail himself of the interpreters service, from the Italian to the English and vice versa, for the purpose of obtaining the precise translation of this Shareholders' Meeting, also for the benefit of those shareholders and members of the Board of Directors who are English speakers.

Upon request of the Chairman and with the unanimous consent of those present, Raffaella Mezzalira, member of the Legal and Corporate Affairs Department, is appointed as secretary of the meeting.

Pursuant to article 5.8 of the Shareholders' Meeting Regulations, the Chairman asks for the assistance of the Chief Executive Officer, Roberto Vedovotto, in order to illustrate the items on the agenda and, more generally, to accomplish all tasks that the Articles of Association and said Shareholders' Meeting Regulations confer to the Chairman.

The Chairman invites the Chief Executive Officer to take the floor and the latter informs those present that:

- a recording system is in place for the purpose of recording the progress of the meeting and facilitating, if necessary, the preparation of the answers to any questions and the successive drafting of the minutes; he also invites the attendees not to introduce any recording machines or cameras or similar equipment;
- pursuant to Legislative Decree no. 196/2003 on data privacy protection, the data of the attendees will be collected and treated by the Company exclusively for the accomplishment of the mandatory corporate requirements;
- as allowed by article 7.5 of the current Shareholders' Meetings Regulations, the presentation and discussion of the items on the agenda, the proposals to the meeting, the voting declarations and

the relevant certifications, as well as the announcement of the resolutions adopted, can also take place and be formulated by the Chairman in English and by the Chief Executive Officer in Italian. Upon the request of the individuals attending the meeting, a simultaneous translation service into the Italian/English language and vice versa is available through earphones. With reference to the subject matters which are discussed in English during the Shareholders' Meeting, for the purpose of allowing a better understanding of the progress of the meeting to the Italian shareholders, the Chairman can avail himself of the support of the Chief Executive Officer, in particular during the meeting discussion;

- At present, no. 4 individuals, representing themselves or through proxy no. 124 shareholders, owning 34.503.096 shares, all duly deposited in compliance with the modalities and terms set forth by the law, equal to 60,721406% of the share capital, are in attendance.

The Chief Executive Officer notifies and acknowledges that:

- the notice of the call of this meeting was published in the daily newspaper "*La Repubblica*" on August 4th, 2011, sent to Borsa Italiana S.p.A. through the NIS (Network Information Service) system and made available to the public on the Company's website at www.safilo.com/it/investors.html;

- the agenda is comprised of the following items:

1. Proposal to increase the number of the members of the Board of Directors from seven to eight; appointment of a new director; determination of the relevant remuneration; pertinent and consequent resolutions

2. Appointment of the Chairman of the Board of Directors; pertinent and consequent resolutions

- the Company has not received any requests for integrations to the agenda, pursuant to Article 126-bis of Legislative Decree no. 58/1998 (T.U.F.);
- the Company has not been asked any question by the shareholders on the items on the agenda;;
- in addition to the Chairman, Melchert Frans Groot, and to himself, the Board member Eugenio Razelli is also in attendance. The following Directors justified their absence: Jeffrey A. Cole, Marco Jesi, Giovanni Ciserani and Massimiliano Tabacchi;
- Paolo Nicolai, Chairman of the Board of Statutory Auditors, Franco Corgnati and Bettina Solimando, Standing Statutory Auditors, are also in attendance;
- the company's share capital amounts to Euro 284,109,825.00, divided into no. 56,821,965 ordinary shares with a par value of Euro 5.00 each;
- with reference to the latest recording on September 30th, 2011, the number of registered shareholders is equal to 30,405;
- the Company does not hold its own shares.

The Chief Executive Officer informs the shareholders and their representatives that:

- the nominative list of the attendees of this meeting, in their capacity as shareholders or attorneys, with the number of shares represented by each attendee, the indication of the delegating shareholders as well as of the attendees voting as pledgees and beneficial owners, is attached to these minutes under letter “A”;
- a summary of the interventions with the indication of the names of the speakers, the answers given and any related comments will be reported in the minutes of the present meeting;
- the names of the individuals who express a contrary vote, abstain from voting or leave the meeting before the vote, and the relevant number of shares owned and/or represented by such individuals, will be reported in the minutes;
- on the basis of the shareholders’ ledger, as completed by the notices received under Article 120 of the Legislative Decree no. 58/1998 and other information made available to the Company, the shareholders in attendance who, directly or indirectly, hold more than 2% of the subscribed share capital of the Company are the following:

The Chief Executive Officer invites the shareholders to disclose any lack of legitimation to the vote pursuant to the applicable law. Nobody having made any declaration in this respect, he assumes that no lack of legitimation to the vote exists. The Chief Executive Officer declares that, as far as the Company knows, no shareholders' agreements pursuant to article 122 of the Italian Financial Act (T.U.F.) exist.

He further informs those present that CONSOB has recommended that experts, financial analysts, qualified journalists and representatives of the auditing firm which certifies the financial statements of the Company attend the meeting; he also reminds those present that it is usual practice of Safilo Group S.p.A. to comply with the above recommendations. As a consequence, consultants and representatives of the auditing firm PricewaterhouseCoopers S.p.A. are welcome as observers.

Also Vincenzo Giannelli, Chief Financial Officer, Barbara Ferrante, Director of Investor Relations and Cristina Andresano, Head of International Communication, managers of the Safilo Group, are in attendance.

Mr. Robert Polet is participating via teleconference.

It is further notified the presence, for operational reasons, of some employees of the Company.

It is notified to those present that:

- the verification on the legitimacy of the proxies has taken place pursuant to article 2372 of the Civil Code and to the Articles of Association;
- the Company has duly fulfilled the information requirements set forth by the applicable provisions of law and regulations with respect to the items on the agenda, since the relevant documentation referred to under article 125-ter of the Italian Financial Act (T.U.F.) (the report on the items on the agenda) has been deposited with the registered office of the company and with Borsa Italiana S.p.A. within the terms prescribed by law.

Furthermore, the aforesaid documentation has been published in a special area of the website of the Company and has been in any case made available and distributed to the shareholders or to their proxies who intervened.

Having said that, the Chief Executive Officer declares the shareholders' meeting validly convened, in single call, in compliance with the law and with the Articles of Association, to discuss and resolve on the items on the agenda.

He informs the attendees of the modalities for the discussion of the items on the agenda and he specifies that, after the introduction of each item, shareholders wishing to speak will be given the floor; he invites all attendees who intend to speak to make a reservation by a show of hands and by giving his/her data. In relation to the interventions that will follow and the relevant questions, such interventions will be preliminarily made and the relevant questions collected.

He recommends those present to intervene briefly on the specific topic under discussion, each intervention shall not exceed 5 minutes, in accordance with article 8.3 of the Shareholders' Meetings Regulations and without prejudice to the possibility, in consideration of the importance of each single

item as well as of the number of interventions booked, to allow a longer duration of each intervention. Upon request, after the clarifications and answers given to the questions, a short reply will be allowed from the shareholders, preferably to be made within 3 minutes and without prejudice to the possibility to allow a longer duration of the reply should the circumstances referred to above occur.

He reminds those present that, upon registration and entry into the meeting room, each shareholder or person entitled to vote and their proxies received an attendance form, it being understood that the proxies have notified the staff in charge, in accordance with the law, of the circumstance by which each of them is attending the meeting in representation of other shareholders.

He invites the shareholders not to leave the room, to the extent possible, during the meeting. Whoever leaves the meeting, even temporarily, shall inform the staff in charge so as to allow the regular course of the meeting and the voting procedures; the procedure records the time of leaving and the time of any re-entry.

The Chief Executive Officer reminds that, before each vote, the number of attending shareholders will be acknowledged, and the personal data of those who declare their intention not to express the vote will be verified. The voting on the items on the agenda will take place by a show of hands and the contrary and/or abstaining shareholders shall communicate their name for the purpose of the minutes.

Lastly, he requests the attendees not to leave the room, to the extent possible, until the voting procedures and the declaration on the outcomes of the vote have been communicated, in view of the fact that, in accordance with the Consob Regulation, the minutes of the Meeting must name those shareholders who leave the Meeting before every vote and specify the related number of their shares.

He starts with the discussion of the first item on the agenda:

1. Proposal to increase the number of the members of the Board of Directors from seven to eight; appointment of a new director; determination of the relevant remuneration; pertinent and consequent resolutions

The Chief Executive Officer asks the Meeting to express its opinion on the proposal to increase the number of the members of the Board of Directors from the current number of seven to eight, and in case the above-mentioned proposal is approved, to express its opinion on the subsequent appointment of the new member and on the determination of his/her remuneration.

The Chief Executive Officer gives the floor to Mrs. Stefania Sammartano, proxy of the shareholder Multibrands Italy B.V., who, in consideration of the fact that all the documentation relating to this item on the agenda - which exhaustively illustrates the reasons which make the increase of the number of the members of the Board of Directors and the appointment of Mr Robert Polet as new Director appropriate and advisable - had been made available to the shareholders, proposes to omit the reading of said documentation and to directly proceed with the discussion.

The Chief Executive Officer takes the floor again and asks the Meeting to express its opinion on this by voting through show of hands; the shareholders, nobody being absent, unanimously approve the proposal.

Lastly, the Chief Executive Officer informs the attendees that no other proposal for the appointment of the new director has been submitted by the shareholders.

After asking the attendees to the Shareholder's Meeting, the Chief Executive Officer declares that there are no variations in the list of attendees.

He reiterates the request to disclose any lack of legitimization to the vote pursuant to the applicable provisions of law and invites, therefore, the shareholders to book their interventions by a show of hands in order to arrange the order of the various interventions.

He declares the discussion open and specifies that, if questions of a technical nature are made, he will have the faculty to suspend the Meeting for the time necessary to prepare the relevant answers.

No shareholder having requested to intervene, he declares the discussion closed and puts to the vote the following proposal of resolution:

"The shareholders' Meeting of Safilo Group S.p.A. resolves to:

- increase the number of the members of the Board of Directors from the current number of seven to eight members;
- appoint a new director, Mr. Robert Polet, who will remain in office until the expiration of the office of the current Board of Directors, *i.e.* until the Shareholders' Meeting called for the approval of the financial statements as of December 31, 2012;
- grant to the new director a remuneration equal to Euro 50,000, *pro rata temporis*, for each fiscal year, besides the reimbursement of the expenses incurred by reason of his office, in line with what was already resolved by the Shareholders' Meeting held on March 29, 2010, in relation to the other members of the Board of Directors."

The above-mentioned proposal is put to the vote through show of hands and it is approved by the Meeting with the following votes:

- no. 34.455.717 votes in favour, corresponding to 99,862682% of the voting capital and to 60,638024% of the share capital;
- no. 47.379 votes against, corresponding to 0,137318% of the voting capital and to 0,083381% of the share capital;
- no. 0 of abstained votes.

All the above as detailed in the schedule attached to these minutes under Annex "B".

The Chief Executive Officer declares the results of the vote and confirms that the resolutions have been approved, so he moves on to the second item on the agenda:

2. Appointment of the Chairman of the Board of Directors; pertinent and consequent resolutions

The Chief Executive Officer reminds those present that, as per the price sensitive press release of August 2, 2011, on that same date the Chairman of the Board of Directors, Mr. Melchert Frans Groot, deemed it appropriate to hand over his office of Chairman (with no prejudice to his office of non-executive member of the Board of Directors) with effect starting from the date of his possible replacement, having he evaluated that Mr. Robert Polet, just appointed, is the most suitable director to hold the office of Chairman of the Board of Directors of the Company.

The Chief Executive Officer gives the floor to Mrs. Stefania Sammartano, proxy of the shareholder Multibrands Italy B.V., who, in consideration of the fact the documentation relating to this item on the agenda had been made available to the Shareholders, proposes to omit reading it and to proceed with the discussion.

The Chief Executive Officer takes the floor again and asks the Meeting to express its opinion on this by voting through show of hands; the shareholders, nobody being absent, unanimously approve the proposal.

The Chief Executive Officer informs the attendees that, since the listing vote mechanism does not apply in this circumstance, article 14 of the Articles of Association will not be applicable to the appointment of the new Chairman too; therefore, the appointment shall be resolved by the shareholders' meeting with the majorities set forth by applicable law.

The Board of Directors remits to the Shareholders' Meeting any decision regarding the replacement of the current Chairman, Mr. Melchert Frans Groot, with the newly appointed director, Mr. Robert Polet. The Chief Executive Officer, after having reiterated the request to disclose any lack of legitimization to the vote pursuant to the applicable provisions of law, invites the attendees to book their interventions by a show of hands in order to arrange for the order of the various interventions.

He declares the discussion open and specifies that, if questions of a technical nature are made, he will have the faculty to suspend the meeting for the time necessary to prepare the relevant answers.

No shareholder having requested to intervene, he declares the discussion closed and puts to the vote the following proposal of resolution:

“The shareholders' Meeting of Safilo Group S.p.A. resolves to appoint Mr. Robert Polet as new Chairman of the Board of Directors of the Company, who shall remain in office until the expiration of the office of the current Board of Directors, *i.e.* until the Shareholders' Meeting called for the approval of the financial statements as of December 31, 2012”.

After recording and elaborating the results of the vote, the Chief Executive Officer communicates the results of the vote:

- no. 34.464.499 votes in favour, equal to 99,888135% of the voting capital and to 60,653480 % of the share capital;
- no. 38.597 votes against, equal to 0,111865% of the voting capital and to 0,067926% of the share capital (California State Teachers Retirement System);
- no. 0 abstained votes.

All the above as detailed in the schedule attached to these minutes under Annex “C”.

The Director Melchert Frans Groot gives the floor to the newly appointed Chairman of the Board of Directors Mr Robert Polet, who thanks for his appointment.

Before closing the Meeting, the Chief Executive Officer thanks the former Chairman for his work and the Shareholders for their participation at the meeting, which he declares closed at 11:30 am.
